Southeast Louisiana, she has made a tremendous impact on the community.


With a forward-thinking and strategic mindset, Chiquita has achieved great

Previously, Patrick was appointed the inaugural Director of the Mayor's Office of Gun Violence Prevention in New Orleans, where he implemented a public health strategy that contributed to a 40% reduction in shootings and murders. Prior to that, he led workforce development initiatives as the Training Manager at the New Orleans Business Alliance, where he connected over 890 formerly incarcerated individuals with employment through the STRIVE® program.

Kellogg Foundation Global Leadership Fellow, Patrick is also a graduate of the University of Chicago's Community Violence Intervention Leadership Academy, Georgetown University's New Strategies Rising Program, and the Nancy M. Marsiglia Institute of Justice at Loyola University. He is the author of A Way Up: Economic Development Post Incarceration, a bold call to action and practical guide for achieving financial literacy and economic empowerment after a conviction. Patrick's visionary work has earned him numerous accolades, including being named Innovator of the Year by the 100 Black Men of New Orleans.
